Discussed the possibility of painting the traffic light posts black (currently silver)

Over the next couple of meetings will look at promo's we can do – does not have to be large event, couple hours on a Friday night or Saturday afternoon. BIA to discuss and consider extending the boundaries of our BIA or look at accepting associate memberships.
